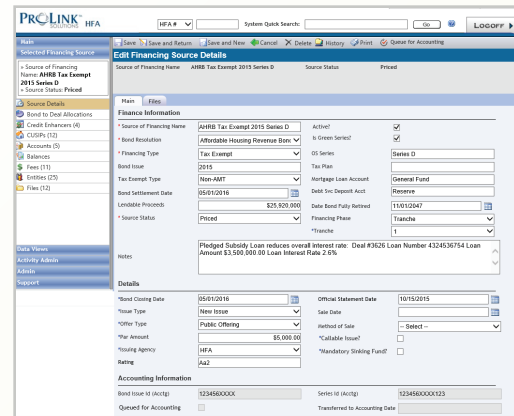

Bond Enhancements

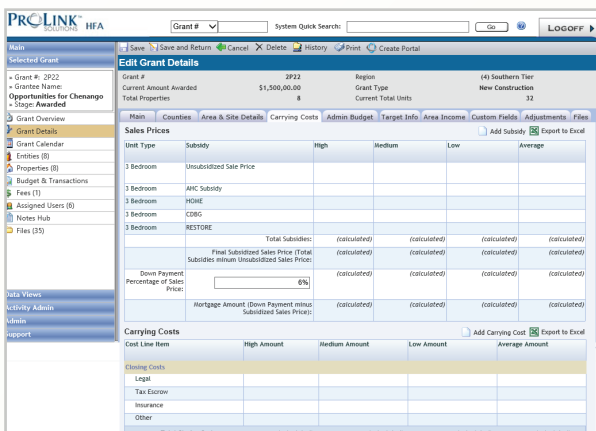

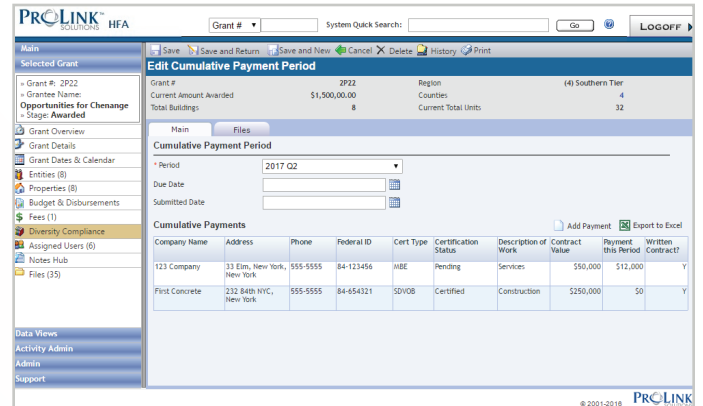

Diversity Compliance

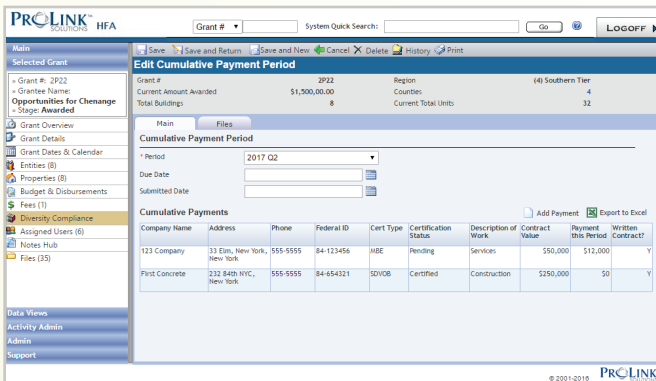
